

TERMS OF USE

You need to read carefully and accept Terms of Use and Privacy Policy before you continue to use this Umbrellapps Portal (website <https://umbrellapps.ovh>). These terms apply to all users, if you disagree with any part of the terms then you may not access the Portal.

USER RULES

- You may access open resources directly without registration or login.
- To access restricted resources marked with a padlock symbol you need to login as guest or register your own account with username and password.
